BUSINESS MEETING:

- 1. Luke and Jodie facilitated our business meeting
- 2. Business Cards Joan Spenser
 - a. Joan got one recommendation for a change and she'll implement them and order/make the cards.
 - b. Hopefully the cards will be ready in time for the October 19th SPT Safety Expo.
- 3. Updates to the WCFSA Web Site
 - a. Can we modify the web site so members can add links to new rules or other recent information?
 - i. We can if we go through our web hosting service but our alliance agreed all no additions would be used without pre-approval.

OPEN SAFETY DISCUSSION:

- 6. Changes to OSHA's Crane Standards
 - a. Our last presentation at Lanier Upshaw (August) was about OH cranes
 - b. Most of the new standard is on mobile cranes the members present suggested a presentation about the mobile crane portion of the standard
- 7. When is a business liable/responsible for the safety or safe performance of an outside service or contractor?
- 8. 2,000 volt main constructed at an outside site. Are there standards for the temporary structure built on site to protect the main? John Wells recommended insuring there is access for the Fire Department and meter reader. Make sure there is a good multi-contractor lockout/tag out program.
